### Our 2010 College Prospects Camp:

Our 2010 College Camp is a unique opportunity for all players entering their sophomore, junior or senior year in high school. This camp is the first of its kind in our region and is designed to provide players with an opportunity to gain valuable exposure to a variety of ACHA college hockey programs before the start of the season and the college selection process. While the camp focuses on college opportunities, a select group of junior teams will also be invited to attend in order to broaden the scope of exposure and opportunity for participating players. ### Camp Features:

**Small Size:** there's no getting lost in the crowd at this camp! Through small size, our players gain the maximum benefit from the camp. The 2009 camp is limited to a total of 68 players. Teams will consist of approx. 2 goalies, 5 defensemen, and 8 forwards allowing each player plenty of ice time in multiple games through the course of the camp.

**Variety of Exposure:** variety is the key to gaining options. We will issue invitations to over 30 colleges and universities as well as to select junior teams which will represent a broad spectrum of educational & hockey opportunities. In today's hockey environment there are opportunities for every player to pursue their goals both on and off the ice.

**Affordable:** At under \$200 per player and featuring multiple ice sessions, we offer you more bang for your buck!

**Game Based:** the on-ice portion of the camp consists of games in which [each player will play multiple games](#) in front of the coaches in attendance thereby maximizing the players' opportunity to showcase their skills. In addition, each player will be considered for the camp all-star game which features the top 40 players in camp based on the merit of their play.

**Information:** this camp features opportunities for players and their parents to gain valuable information through our Hockey Opportunities/College Hockey Seminar as well as in our Meet & Greet Session. The Meet & Greet Session is designed to allow players and parents an opportunity to meet and speak with many of the coaches and scouts in attendance. These networking opportunities provide a valuable resource that can help a player find the right opportunity!

### Camp Details:

**Format:** This camp is game-based. Team assignments and jerseys will be available at check-in. Each player will play a minimum of 3 games and a maximum of 4 games (if selected for the camp all-star game).

**Teams:** Teams will be constructed by the camp staff and consist of a maximum of 2 goalies, 5 defensemen, and 8 forwards.

**Games:** will consist of a warm-up and two halves. Ice cuts and goaltender changes will take place at each half.
